

## 30th ANNUAL GENERRAL MEETING HELD ON SEPTEMBER 25, 2014 DECLARATION OF RESULTS OF E-VOTING & POLL ANNOUNCED ON SEPTEMBER 26, 2014

The Company had in pursuant to the provisions of Section 108 of the Companies Act, 2013, read with the Companies (Management and Administration) Rules, 2014 and clause 35B of the Listing Agreement, provided e-voting facility to the members to cast their votes electronically on all resolutions set forth in the Notice convening the 30th Annual General Meeting which is held on September 25, 2014. The e-voting was open from 18th September, 2014 to 20th September, 2014.

In line with the provisions of the Companies Act, 2013 and in terms of the clarification issued by MCA, voting by show of hands was not permitted at the general meeting where e-voting has been offered to the Shareholders. Therefore, at the 30th AGM, voting was conducted by means of poll.
